### Background


The InCELL Hunter technology measures intracellular compound-target engagement by detecting changes in protein stability due to compound binding. In this assay, the target is fused to the enhanced ProLabel<sup>®</sup>(ePL) enzyme fragment and expressed in the selected cell background. The amount of fusion is quantified through the addition of substrate and complementary enzyme acceptor fragment (EA). The small size, but robust activity of the ePL tag makes it an ideal fusion partner. The small disordered peptide has minimal effects on target half-life, and generates high levels of enzyme activity, resulting in a sensitive measurement of protein levels.

## **Functional Performance**

Cells were seeded in a 384-well plate, incubated at  $37^{\circ}$ C and 5% CO<sub>2</sub> followed by stimulation with a control compound, as defined in the assay conditions below. Following treatment, signal was detected using the InCELL Hunter Detection Kit according to the recommended protocol using the conditions specified below. Please refer to page 2 for recommended assay reagents, detection reagents, and control compounds.
