# ChemiScreen<sup>™</sup> P2Y<sub>2</sub> Purinergic Receptor Stable Cell Line

CATALOG NUMBER: HTS210C

**CONTENTS**: 2 vials of mycoplasma-free cells, 1 mL per vial.

**STORAGE**: Vials are to be stored in liquid N<sub>2</sub>.

## **BACKGROUND**

ChemiScreen cell lines are constructed in the 1321N1 host, which supports high levels of functional receptor expression on the cell surface. 1321N1 cells contain high endogenous levels of  $G_q$ , a promiscuous G protein, allowing most receptors to couple to the calcium signaling pathway.

The P2Y GPCRs serve as receptors for extracellular nucleotides (Abbracchio *et al.*, 2006). P2Y<sub>2</sub> (also known as P<sub>2U</sub>) is activated by UTP and ATP, and couples to  $G_q$  to increase intracellular calcium (Parr *et al.*, 1994). The P2Y<sub>2</sub> receptor knockout mouse displays defective nucleotide-stimulated Cl secretion, and a P2Y<sub>2</sub> selective agonist increases tracheal epithelial chloride and water secretion (Cressman *et al.*, 1999; Yerxa *et al.*, 2002). As a result, P2Y<sub>2</sub> is a potential target for treatment of cystic fibrosis. In addition, the P2Y<sub>2</sub> KO mouse displays salt-resistant hypertension (Rieg *et al.*, 2007). The cloned human P2Y<sub>2</sub>-expressing cell line is made in the 1321N1 host, which supports high levels of recombinant P2Y<sub>2</sub> expression on the cell surface. Thus, the cell line is an ideal tool for screening for agonists and antagonists of P2Y<sub>2</sub>.

Calcium Flux Fluorescence Assay

#### **APPLICATION DATA**

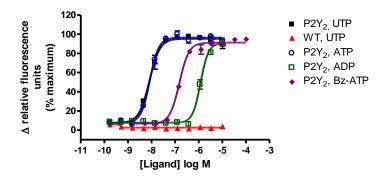


Figure 1. These are representative data for activation of the P2Y<sub>2</sub> receptor stably expressed in 1321N1 cells induced by UTP, ATP, Bz-ATP and ADP using a fluorescent calcium flux assay. P2Y<sub>2</sub>—expressing 1321N1 cells were seeded at 50,000 cells per well into a 96-well plate, and the following day the cells were loaded with a fluorescent calcium indicator. Calcium flux in response to the indicated ligand with a final concentration of 0.5% DMSO was determined on a Molecular Devices FLIPR<sup>TETRA®</sup> with ICCD camera. Maximal fluorescence signal obtained in this experiment was 9,000 RLU. Similarly parental cells were tested to determine the specificity of the resulting signal.

## **Discovery Services**

## **Cell Handling**

- 1. Upon receipt, directly place cells in liquid nitrogen storage. Consistent cryopreservation is essential for culture integrity.
- 2. Prepare Basal Medium. Prepare 37°C Water Bath. Thaw cells rapidly by removing from liquid nitrogen, and immediately immersing in a 37°C water bath, until 90% thawed. Immediately sterilize the exterior of the vial with 70% ethanol.
- 3. Add vial contents to 15 mL Basal Medium in T75 Tissue Culture Treated Flask. Gently swirl flask and place in a humidified, tissue culture incubator, 37°C, 5% CO<sub>2</sub>.
- 4. 18-24 Hours Post–Thaw, all live cells should be attached. Viability of the cells is expected to be 60-90%, At this time, exchange Basal Medium with Selection Medium.
- 5. When cells are approximately 80% confluent, passage the cells. It is suggested that user expand culture to create >20 vial Master Cell Bank at low passage number. Cells should be maintained at less than 80% confluency for optimal assay results.
- 6. Cell Dissociation: Aspirate Culture Medium. Gently wash with 1x Volume PBS. Add 0.1x Volume Warm Trypsin-EDTA. Incubate 4 min, 37°C, until cells dislodge. *If cells do not round up, place in 37°C incubator for additional 2 min.* Neutralize Trypsin and collect cells in 1x Volume Basal Medium.
- 7. Seed Cells for expansion of culture. It is recommended that cell lines are passaged at least once before use in assays.

## **Assay Protocol – Fluorescence**

- 1. Dissociate Culture as Recommended. Collect in Basal Medium. Document Cell Count and Viability
- 2. Centrifuge the cell suspension at 190 x g for six min
- 3. Remove supernatant. Gently resuspend the cell pellet in Basal Medium. *It is suggested that end user optimize cell plating based on individual formats.* (Default: Resuspend in volume to achieve 5x10<sup>5</sup>cells/ml (i.e, if collected 5e6 TC, <sup>5e6/</sup><sub>5e5/ml</sub> =10 mL volume)
- 4. Seed cell suspension into black, clear bottom plate (100 μL/well for 96-well plate). When seeding is complete, place the assay plate at room temperature for 30 min.
- 5. Move assay plate to a humidified 37°C 5% CO<sub>2</sub> incubator for 18-24 h.
- 6. Next day, prepare Assay buffer (HBSS, 20mM HEPES, 2.5 mM Probenicid, pH 7.4) and Loading buffer (Assay buffer with 5 mM Fluo8 Dye). *Note: Please prepare Fluo8 stock according to Manufacturer's Recommendations*
- 7. Remove medium from assay plate and wash 1X with Assay Buffer.
- 8. Add Loading buffer to assay plate (100  $\mu$ L/well for 96-well plate). Incubate plate for 1.5 h at room temperature, protected from light.
- 9. Prepare ligands in assay buffer at 3x final concentration in non-binding plates. Use Buffer Only Control Wells for Background Subtraction.
- 10. Create protocol for ligand addition. Please refer to FLIPR<sup>TETRA</sup>® settings provided in Table 2. Set time course for 180 s, with ligand addition at 10 s.
- 11. After the run is complete, apply subtract bias on sample 1. We recommend using Negative Control Correction with Buffer Only Wells. Export data to according to research needs. For most Calcium Flux analysis using Export of Max Signal to end of run is sufficient.

1321N1, an adherent cell line expressing the promiscuous G-protein, G<sub>a</sub>.
