

# PathHunter® eXpress CCR5 Activated GPCR Internalization Assay

## **Background**

PathHunter eXpress Activated GPCR Internalization cells are engineered to co-express an untagged GPCR, Enzyme Acceptor (EA) tagged  $\beta$ -Arrestin, and a ProLink<sup>TM</sup> (PK) tag localized to the endosomes. Activation of the GPCR induces  $\beta$ -Arrestin recruitment, followed by internalization of the Receptor/Arrestin-EA complex in PK-tagged endosomes. This forces complementation of the two  $\beta$ -galactosidase enzyme fragments (EA and PK), forming functional enzyme that hydrolyzes substrate to generate a chemiluminescent signal. These cells have been modified to prevent long term propagation and expansion using a proprietary compound that has no apparent effect on assay performance.


